A RESOLUTION APPOINTING TWO AT-LARGE MEMBERS OF THE CITIZENS ADVISORY COMMITTEE (CAC) OF THE PUEBLO AREA COUNCIL OF GOVERNMENTS TRANSPORTATION ADVISORY COMMITTEE FOR THE PUEBLO AREA METROPOLITAN PLANNING ORGANIZATION (MPO)

WHEREAS, three citizens representing a diverse range of interests in the Pueblo area transportation community and the Pueblo community-at-large are appointed by the PACOG Board to serve as Citizen Advisory Committee representatives to the PACOG Transportation Advisory Committee; and

WHEREAS, a public notice was published in the Pueblo Chieftain on September 28, 2014, October 5, 2014, and October 12, 2014, with a deadline of receipt of applications on October 13, 2014; and

WHEREAS, two citizen representatives are to be appointed to the Citizen Advisory Committee to fill seats currently filled by Kristen Castor and Laurie Clark.

NOTICE OF APPLICATION FOR AT-LARGE APPOINTMENT

The Pueblo Area Council Of Governments (PACOG) is accepting applications for two (2) at-large appointments to the **Citizens Advisory Committee (CAC)** of the **Transportation Advisory Commission (TAC)** for short and long range regional transportation planning. Each appointment is for a period of two (2) years and is open to anyone residing in the City or County of Pueblo. The nine (9) member CAC is comprised of three (3) at-large appointments, and six (6) other members representing the City and County Planning Commissions, the 2020 Commission, and PEDCO.

The TAC is responsible for reviewing transportation studies and providing the PACOG Board with recommendations for long range (25-30 years) multi-modal transportation plans. The TAC and the Colorado Department of Transportation (CDOT) collaborate in the development of the Long Range Transportation Plan for the Pueblo Urbanized Area that is incorporated into the State of Colorado's Statewide Transportation Plan, as well as the four-year Transportation Improvement Program (TIP) that becomes a part of the Statewide Transportation Improvement Program (STIP), and planning for all transportation system components including:

- MAJOR REGIONAL CORRIDORS (roadways and other modes)
- TRANSPORTATION SAFETY AND SECURITY
- PEDESTRIAN TRAILS, SIDEWALKS AND SUPPORT FACILITIES
- REGULAR AND SPECIAL TRANSIT SERVICES
- FREIGHT MOVEMENT AND INTERMODAL TRANSFERS
- ECONOMIC DEVELOPMENT INTERACTIONS
- COMMERCIAL AND GENERAL AVIATION OPERATIONS
- ENVIRONMENTAL AND LAND USE INTERACTIONS

TAC regular meetings are held on the first Thursday of each month from 8:30am – 10:30am at the Pueblo City Council Chambers. Special TAC, committee, or subcommittee meetings may also be held to consider specific transportation issues affecting the PACOG region (all of Pueblo County). All meetings are open to the public and are ADA accessible.
