CDOT Region II had notification of five (5) policy amendments to the PACOG Transportation Improvement Program (TIP) and the Statewide Transportation Improvement Program (STIP) in the MPO/TPR area.

Phase one includes I-25 access from both the north and south, overpass, and roundabouts on both sides. Phase one does not include the Dillon extension to American Furniture Warehouse area.

Mr. Hobson reported the Pueblo Transit Small Urban Awards Various Projects are: Replacement of security system at bus terminal \$25,000 (Award \$20,000; Local Match \$5,000), Purchase and replace security cameras on buses \$66,500 (Award \$53,200; Local Match \$13,300), Purchase 2 diesel Paratransit ADA vans \$126,000 (Award \$100,800; Local Match \$25,200), Purchase equipment for 4 buses left from previous project \$34,400 (Award \$27,520; Local Match \$6,880), Purchase 3 desktop, 1 laptop computers for replacement, 1 monitor \$5,000 (Award \$4,000; Local Match \$1,000), Purchase a tire balancer \$10,000 (Award \$8,000; Local Match \$2,000), and Purchase a bus lift to replace obsolete one in shop \$21,626 (Award \$17,301; Local Match \$4,325).
