Mr. Scott Hobson reported a shortfall in the original engineering estimate for the US 50 Signal Timing Project. There was originally \$273K programmed for the Project and bids came in at \$44,336 over the programmed amount.

Also, Mr. Hobson reported a TIP Amendment estimated at \$850K additional funds for the 4th Street/SH 96 Signalization Project may be submitted by CDOT in the next week or two. In an effort to make sure the amendment can make it to PACOG on June 26, 2014 he asked if the TAC/CAC members would be willing to make a recommendation via email prior to June 16, 2014. Members agreed to this and if the TIP is submitted by CDOT in time, a recommendation will be asked of the TAC/CAC via email.

5. Travel Demand Model Presentation with HDR Engineering, Inc. – Maureen Paz de Araujo Phase 1 Milestones: PACOG Travel Demand Model Evaluation, Update and 2040 RTP Support

Ms. Maureen Paz de Araujo presented a PowerPoint Slideshow to the TAC/CAC members which gave an update on the data collection process, status, and data usage for the first phase of the PACOG Travel Demand Model. Though phase two has technically not really started HDR and Consultants have began the second phase of the Model. The TAC/CAC members were interested in knowing if there could be more of an incorporation of pedestrian and cyclist information in the Model.

- Transportation Alternatives Program (TAP) Review Mr. Scott Hobson reported there are
 adjustments to the criteria and recommended anyone who had qualified projects to review the
 criteria prior to submission. The TAP applications are due electronically on June 15, 2014. Ms.
 Wendy Pettit stated final dollar amounts are not required for the application and CDOT is looking
 more for a conceptual idea. Mr. Hobson stated the City is potentially submitting a couple of projects
 but the 20% local match may be difficult to come up with at this time. Additional questions are to
