We are proposing to add \$700,000 of Regional Priority funds to the project to make the needed repairs to the bridge deck and do a two-inch mill and fill procedure to the surface of the bridge on I-25. This project will be completed in conjunction with the Baltimore to Wills project.

Ms. Pettit reported that this project was pooled in this TIP request to manage as on one project so both projects can go out to bid. The money is 100% state money that came from elsewhere in the state's program funding. There will be a future TIP request to complete the Baltimore/Wills project.

- (5) **MPO Staff Report – Scott Hobson and Pepper Whittlef**

**(a) TIGER GRANT – Presented by Pepper Whittlef, MPO Staff**

Ms. Whittlef reported that CDOT submitted the Pueblo Dillon Flyover project application to the Transportation Commission. It was one of two requests from Colorado for the TIGER IV grant program and has a good chance getting awarded the federal grant. Phase 1 of the project completes half of the bridge and is scheduled to start in the spring of 2012. A TIGER IV grant would make it possible to complete Phase 1 & 2 of the Dillon Flyover and save money on the project.

**(b) Long Range Transportation Plan – Presented by Scott Hobson, MPO Staff**

Mr. Hobson presented the key elements of the 2040 Long Range Transportation plan for 2012. He said that the 2012 Demographic information, scope of work and timing of the public information process are some of the preliminary elements. MPO staff is conferring with CDOT on how to use salary savings as transportation planning funds to contract consultants to complete certain scopes of work. The last MPO request was a UPWP transfer of \$30,000 for the *Downtown Pedestrian Transportation Plan Study*. The timeline for presenting the 2040 LRTP to the state is by the end of 2014 for final approval in 2015.

**(c) Regional Transportation Authority Update – Presented by Earl Wilkinson, Director of Public Works**

The city and county of Pueblo are in the planning process for an RTA (that promotes a *local* solution to state and federal funding shortfalls) for voters to approve the *levy* of a 1-cent sales tax. Percentages would be defined and identified for allocation to a list of projects such as capital improvements, maintenance and metro transit that can be accomplished without the restrictions in using federal and state funds. Ms. Castor suggested scheduling several public meetings because the public needs to be educated on the benefits of RTA in order to pass it. Mr. Wilkinson reported that public meetings will be scheduled.

**(d) 2012 Transportation Enhancement Grant Information – Presented by Wendy Pettit, CDOT Region 2 Planner**

Ms. Pettit gave the schedule of the Transportation Enhancement applications process for 2013 funds. They are due April 20, 2012 and the review period follows thru the final review date of June 29, 2012. At present there are four applications for the City of Pueblo and one from Pueblo West applying for the available funds for 2013. She also reported that Pueblo West was awarded funds from the Safe Route To School program for school *crosswalk flashing signals* in the 45 mile posted traffic zones.
