

RESOLUTION NO. 2022-011

A RESOLUTION IDENTIFYING A 10-YEAR PIPELINE OF LOCAL ON-SYSTEM HIGHWAY, BRIDGE AND TRANSIT PROJECTS OF THE COLORADO DEPARTMENT OF TRANSPORTATION (CDOT) FOR THE PUEBLO MPO AND TPR PLANNING REGION

WHEREAS, 49 CFR Part 613.100 and 23 CFR Part 450.322 require the development through the continuing, cooperative, and comprehensive ("3C") multimodal transportation planning process a fiscally constrained Regional Transportation Plan (RTP) for Metropolitan Planning Organizations (MPOs); and

WHEREAS, pursuant to the aforementioned legislation, the Pueblo Area Council of Governments (PACOG) was designated by the Governor of the State of Colorado as the MPO agency responsible for carrying out the transportation planning process, and for developing and amending the Long-Range Transportation Plan (LRTP); and

WHEREAS, the Pueblo Area Council of Governments (PACOG), as the Pueblo MPO and the designated Transportation Planning Region (TPR) for the Pueblo area, has reviewed the existing adopted 2045 Long-Range Transportation Plan On-System and Transit Projects; and

WHEREAS, the PACOG planning staff has developed in coordination and cooperation with the Colorado Department of Transportation Region 2 and member agencies of PACOG a 10-year pipeline list of transportation capital improvements; and

WHEREAS, the attached list is NOT intended to be all inclusive of the transportation investment needs of the Pueblo Planning Area; and

WHEREAS, the 10-year pipeline of projects is intended to bridge the gap between the 4-year Transportation Improvement Program and 25-year LRTP.

NOW, THEREFORE, BE IT RESOLVED BY THE PUEBLO AREA COUNCIL OF GOVERNMENTS that:

SECTION 1:

The Pueblo Area Council of Governments hereby requests CDOT to incorporate the attached list of projects into their 10-year pipeline development plan for the 2045 Statewide Long-Range Transportation Plan, and incorporate additional projects identified through the Transportation Planning Process as identified.


SECTION 2:
