RESOLUTION NO. 24-011

A RESOLUTION AMENDING THE SCOPE OF THE AWARD OF \$2,000,000.00 IN MULTIMODAL TRANSPORTATION AND MITIGATION OPTION (MMO), AND CARBON REDUCTION PROGRAM (CRP) FUNDS FROM THE BOULEVARD EXTENSION TRAIL BETWEEN PUEBLO BOULEVARD AND PURCELL BOULEVARD TO THE BOULEVARD EXTENSION TRAIL PROJECT FROM 24TH STREET TO 11TH STREET.

WHEREAS, Colorado Senate Bill (SB) 2021-260 generated \$2,000,000.00 dedicated funds for MMO Projects, in the Pueblo Area Council of Governments (PACOG) planning area; and

WHEREAS, said MMO funds of \$1,452,208.00 and CRP funds of \$547,792.00 was received on July 28, 2022 and approved by Resolution 2022-014 for the design and construction of a 12' asphalt multiuse trail from Joe Martinez Boulevard and Purcell Boulevard across the Honor Farm, parallel to the Joe Martinez extension (Medal of Honor Boulevard) to Pueblo Boulevard and continue south at Pueblo Boulevard to 11th Street, including two trail-heads and two EV charging stations.

WHEREAS, due to the increase in construction costs of the original grant award said MMO funds in the amount of \$1,452,208.00 and CRP funds in the amount of \$547,792.00 will be used for the design and construction of a 1.3-mile north/south trail from 24th Street to 11th Street along the west side of Pueblo Boulevard (SH45) and resurfacing and signage update at 11th Street trail head.

NOW, THEREFORE, BE IT RESOLVED BY THE PUEBLO AREA COUNCIL OF GOVERNMENTS that:

SECTION 1:

The Pueblo Area Council of Governments expresses its desire to use its SB2021-260 Multimodal Transportation and Mitigation Option and Carbon Reduction Program of \$2,000,000.00 for the design and construction of the Boulevard Extension Trail from 24th street to 11th street which will promote an integrated multimodal system.

SECTION 2:

The PACOG certifies that the transportation planning process is being carried out in conformance with all applicable federal requirements; and hereby directs the Urban Transportation Planning Division to implement the necessary revisions to the Fiscal Year 2023–2027 Pueblo Metropolitan Planning Organization (MPO) Transportation Improvement Program to include this amendment.
