Transportation System A.K.A Transportation Fee Bill-CDOT HQ-Andy Karsian

Action Requested: Informational

Andy Karsian said that Senate Bill (SB) 260 passed in the legislator meeting. In his presentation, he talked about what Colorado needs, accountability, climate goals, and transparency. There will be \$3.784b in new fee revenue, \$1.581B in General Funds & Stimulus Dollars for a total of \$5.365B (10-year average). The new fees come from Road Usage, Bridge and Tunnel Enterprise, EV Equalization, TNC, Delivery, Personal Car Share, Rental, Taxi, and Autonomous Vehicle. They will not be implemented until a few years.

\$734m will go towards Charging Infrastructure & Electric Vehicle Equity, Fleet Electrification Incentives, and Public Transit Electrification.

The 10-year plan will almost be fully funded. The fees will be collected from the Department of Revenue.

5. Connected Vehicles in Colorado-Presentation- CDOT HQ-Ashley Nylen, PMP

Action Requested: Discussion

Ashley Nylen informed us that a connected vehicle (CV) is a vehicle equipped with technology, that allows the vehicle to send information to roadways operators or other users for decision making. This means that cars can talk to other cars. This is to improve safety. An example would be that an ABS (Antilock Braking System) has been triggered and can communicate to any users in the area and sends that to the management (message board). This may mean that the drive hit the brakes because of ice. Data, Practical Innovation, and Collaboration are the 3 main pillars of the Connected Vehicle Program. The CV infrastructure includes Hardware (Physical Environment) and Software (Digital Infrastructure). Hardware is the Roadside units (RSU) and onboard units (installed on vehicles). Software includes the fiber, data collection, storage, and processing. There are 6 Core Principles that include Statewide Approach of CV Assets (physical and digital), Cohesive RSU Infrastructure buildout, Connected to Fiber, Technology neutral solutions, Open-source Digital Assets, and Enabling Interoperability.

The plans now are to buildout the base system (Sept 2021), Functionality Testing (Oct 2021), and Documentation and Technology Transfer (Oct 2021). Phase 3 will be in Nov 2021-Oct 2022, this includes Ecosystem Enhancements, Digital Infrastructure Interrogation, Psychical Infrastructure Expansion, and Document, Testing, Validation, and QA/QC. Jawadi asked who will pay for the upgrade to the Traffic Signal, Ashley said they have not tapped into that yet but there is a variety of options to integrate. There will be a pilot program with a snowplow. Eva Cosyleon asked how cars will be equipped. Ashley said that cell phones and the driver would need to opt in. Don Bruestle asked if they are an international entity, Ashley said that they are a part of the Federal Communication Commission, Society of Automobile Engineers, and other groups. 6. I-25 Update - CDOT Region2-Joe DeHeart

Action Requested: Discussion

The I-25 Pueblo Environmental Impact Statement (EIS) was done in 2000, final EIS was signed in 2013, the Record of Decision (ROD) - Phase 1 signed in 2014, includes Pueblo Blvd Interchange to Hwy 50/47, and the official purpose (Safety and Mobility). The ROD commits FHWA and CDOT to build improvements in the plan and mitigates the resources that will be disturbed by the improvements (IE-noise). ROD North can only be prepared in an area that can show funding in the Long-Range Transportation Plan. The funds were going to come from normal future sources. New Pueblo Freeway includes I-25 and Ilex, City Center to 13th St, Mineral Palace Park, Hwy 50B (K-18-J and K-18-L Bridge), Dillon Extension, and 29th St Interchange. Joe DeHeart has a few slides of visuals for all the projects. Joe said that they are currently working on Hwy 50B. John Adams asked how long the ROD will last, Joe said that they last 10 years but if there is no activity then there is a re-evaluation. Jawadi asked about the ADT proposed on I-25, Joe said that will be in 2045 LRTP. The Dillon Extension is not part of this project.
