Adding Additional Funds: The current design of the project on US 50B is approximately 15 miles of roadway beginning just east of the intersection of 50B and Bonforte and ending with the intersection of 50B and Avondale. The project will consist of mainly a 2.5" mill and fill throughout the whole project. There will be some minor structure work done on ten different structures including a mill and fill, installing waterproofing membrane, placing riprap and cleaning and patching spalled areas. Lastly, the project will also contain a reconstruction area near MP 319 where structure K-18-W is located to try and increase clearance in the underpass. The reconstruction will consist of 8.5" asphalt and 12" of ABC; this area will also include drainage upgrades and slope pavement replacement.
