Dylan Goodman went over the 2025-2028 TIP Tracker, he mentioned that the colors have been changed to a pastel green, blue, and pink. Every project has its own project line and then the funding categories are listed. Laura's comments were asking about our acronyms, going into more details of the TAC vs TTC(Transportation Technical Committee) / CAC (Citizen Advisory Committee). Dylan said that the acronym list was pulled from the Statewide Transportation Advisory Commission (STAC). Eva Cosyleon asked CDOT if this gets looked over to remove outdated names, Geoff Guthrie wasn't sure. The other item that was added is the fiscally constraint list project. This is what we currently have or what is programmed and what we have left. Geoff Guthrie asked what program means, Dylan said that it means the funds exist. Geoff said that the project has a funding placeholder. These include the Carbon Reduction Program (CRP), Multi-Modal Transportation and Mitigation Option Funds (MMOF), and Transportation Alternatives Program (TAP) funding, which means that the MPO has project funding.

# 5. MMOF City of Pueblo Parks & Recreation Request: Trail Signs\* Action Requested: Presentation

Eva Cosyleon said there is about \$512,000 left in the MMOF. Steven Meier informed everyone that it has been a challenge getting signage (vandalized) and even getting to the river (wayfinding). He is looking at getting a better sign system to identify access points, get people to the trails, etiquette signs, and reminder signs (pick up dog poop, etc...) There are a few maps of the location and dimensions of the signs. Mile Marker 0 will be at the confluence. Don Bruestle suggested using clear identification for the trails, Steven said .5A would be for .5 mile at the Arkansas River. Lachelle Davis asked what the funds will be used for, Steven said this will be used for buying materials. Melanie Turner asked if the big signs can be installed, Steven said that they don't know on which designs and will decide internally. Geoff Guthrie suggested facing these north to prevent sun damage. Cheryl Spinuzzi suggested using some sort of film on the signs, Steven said he has mixed feeling on those. Eva Cosyleon suggested using pictures instead of text and using correct colors. Don Bruestle asked if they will be using "you are here", Steven said that that is what the QR code will be. Eva also suggested adding Transit stop symbol. Tura Cowan asked about the height of the signs, Steven said they are about 7 feet. She said that her chair can elevate to read it better and others do not. Tura suggested adding brail, Steven said the mile markers and etiquette signs will have brail. Lachelle Davis said that they still need to go through the local agency process. Eva said that the remaining balance is a little over \$525k. She also reminded everyone to look over the criteria.

# 6. Industrial and Purcell Intersection Design Update

**Action Requested: Informational** 

Greg George said they are about to launch the design work, there were 7 consultants and they narrowed is down to 1 after phone interviews. Rocksol is the company. They are going to do part of the potential land acquisition if needed. They are waiting for documents from CDOT to get started. Melanie Turner asked about widening, Greg said that they could work with 2 corners. The control box has been moved. The southwest corner would also work because the owner will give up Right-of-Way (ROW). The northwest corner is a stormwater basin, so this might not work. Eva Cosyleon asked how many crashes, Greg said that location is number one but didn't have the numbers. The sidewalk will be moved to the east at the next intersection. Cheryl Spinuzzi asked about the planning/zoning process, Greg said it goes to the Metro Architectural Advisory Board then County Planning.

Hannah Haunert said that the intersections of Hwy 47 and Dillon and Hwy 50 W and Elizabeth St tied with 33 crashes. She did break them down into crash types which include Broadside, Rearend, Approach Turn, and Other. She also included how many were serious injured and fatalities. There were a pedestrian crash at Hwy 50 and Club Manor Dr, Northern Ave and Prairie Ave, Hwy 50 and Bonforte Blvd/Hudson Ave, Hwy 45 Pueblo Blvd and Northern Ave, Hwy 45 and Red Creek Springs Rd/Rutgers Ave, and Hwy 96 and Elizabeth St. There were also fatalities at Northern Ave and Prairie Ave, and 2 at Northern Ave and Orman Ave. She also included a few maps of the crash locations and fatality locations. The crash map shows the ranking number. Melanie Turner said that these will always be the top locations because they are the highest volume. The Safe Street for All grant has been awarded and will include 11 City and 4 County intersections to use AI technology for a study. The next phase will be a large public outreach. Greg said that these problem spots will help build the standard. He also mentioned that they are closely working with the Sheriff's department for speeding. Dylan Goodman asked if anyone has looked at cheap traffic controller quick build (re-engineer the roadway temporarily). Greg said that they did lane calming, data says it did calm some. Don Bruestle said that he spoke to the City's Traffic Enforcement, and he said they don't have a lot of staffing.

#### 8. June Bike Month\*

## **Action Requested: Informational**

The MPO, Grassroots Gravel, and Pueblo Active Community Environments (PACE) have been working on Pueblo Bike Month Bingo. There is a QR code you can scan with your phone that will take you to the website. We wanted to create a really fun bingo card to get people out and try different events. The kickoff is at the AMR Safety Jam at Lake Minnequa. If you get a certain number of bingos then this could be turned into raffle tickets. The Grand prize is a new Belgium Bicycle. There is also a photo contest. Don Bruestle said that PACE is about connectivity and walkability too.

## 9. TAC ByLaws\*

# **Action Required: Discussion**

Dylan Goodman said he needs to add a section about the Citizen at Large is selected, and members serving as their organization, and to remove the consecutive served terms. He made changes to absenteeism/unexcused absences, and the management and oversight of the sub committees is left to the vice chair. After TAC Approval, it will get sent to the PACOG Attorney, after that, then it will be presented to the PACOG Board, then we will work on the PACOG Bylaws. The PACOG Meeting consists of Water Quality, Environmental, CDOT, Transportation Commission, Front Range Rail, Statewide Transportation Advisory Commission (STAC), etc... There is a slight difference in an MPO (PACOG) update vs TAC update. Cheryl Spinuzzi said that it should be stated that the Chairperson/Vice Chair is voluntary. Dylan did inform everyone that the duties are relatively limited so that it can be expanded on the future. Eva Cosyleon said that the Chair could present to PACOG as needed.

Dylan went over the term limit, and how the alternative needs to be approved through the same process. Cheryl suggested adding something about having a good standing with PACOG. She also suggested having the chair/member removed for being disruptive. It was suggested that the members could read Director of Blank or their designee, but their designee can only be changed once a year. The only one that will need a schedule is for the At Large Citizen, September timeframe to vote.

Don Bruestle asked about instituting a policy on free fares for Pueblo Transit, subsidized by City Council.

## 10. Other Local Agencies Updates

# **Action Requested: Informational**

Ben Valdez said that they will be negotiating on the Vanpool next week with the vendor that has been selected. This is to transport workers from the City and County to the Industrial area. There is no schedule, the employees sign up for the service. There will be negotiations on wheelchair accessible. He had a concern about the funding lapse from award to receiving. He has RFP's that are ready to go but the funding isn't there. The new bus routes for the north/south shopping will start on June 3<sup>rd</sup>.

Greg Goerge said that the overlay project will include 1.62 miles in Pueblo West and 10 miles in Pueblo County. Chip and slurry will be 23 miles and include 90 roads. There is also dust treatment. Eva Cosyleon asked about bike lanes and Greg said there isn't a finalized list.

Andrew Hayes said that the rest of Northern Ave (Prairie Ave to I-25 bridge) will be paved. Concrete work is finishing up on Dillon by northside Walmart. The contract awards are ready for Bonforte Blvd, this will get the improvements it needs especially from the walk audit that was done. Paving will be next season. Eva Cosyleon asked if they will be adding new ADA curb ramps or mid-block crossing to Bonforte, Andrew said that there is potential. Melanie Turned mentioned that the Bonforte and Jerry Murphy signal should be replaced. Granada Blvd from Lowe's to Farabaugh will be paved this year. Andrew said that they have the resolution to award The Safe Streets for All Grant. This is to have AI study a few different intersections throughout the City and County. These also include the highest crashes. Don Bruestle asked about Court Street south of 17th Street, Andrew said it will be worked on later this year. Utility work is still being done. Don also asked about crown work, Andrew said that it will be managed but still there. The RAISE Grant IGA has been finalized; it is in legal review.

Chuck Lopez from Transit said that they might do free fare for better air but for youth, Eva said that we already have that and suggested opening it up for everyone.

Shawn Winters said TAP 4 and 5 have been submitted for final specs, request for clearance. Purcell Trail design option letter, and Civic Center waiting for IGA. FLAP Project bridge deck has been poured, full completion in June.

#### 11. CDOT Updates

Geoff Guthrie said that I-25 from MM 92 to 103 is going to get rehabilitated. There will be nighttime operations north of Exit 94 Pueblo Blvd. Melanie Turner suggested if the business owners will be notified about the reconfiguration/striping on Hwy 45 Pueblo Blvd (from I-25 to 11<sup>th</sup> Street). Don Bruestle suggested restriping Midtown north of 4<sup>th</sup> Street.

Aaron Willis said that Policy Directive 14 is the Performance Measures and will go to the Transportation Commission.

# BYLAWS OF THE TRANSPORTATION ADVISORY COMMISSION (TAC) OF THE PUEBLO AREA COUNCIL OF GOVERNMENTS (PACOG)

#### **ARTICLE 1: NAME**

The name of this Commission shall be the Transportation Advisory Commission of the Pueblo Area Council of Governments.

#### **ARTICLE II: ORGANIZATION**

#### Section 1. AUTHORITY

The Commission shall be governed by the policies and guidelines set forth by the Pueblo Area Council of Governments or as amended.

#### Section 2. AREA

The area to be served by the Commission is the County of Pueblo.

#### Section 3. NONDISCRIMINATION

No person or organization shall, on the grounds of race, color, national origin, religion, creed, sexual orientation, gender identity, or handicap, be excluded from participating in, be denied the benefits of, or be subject to discrimination from the Commission.

#### **ARTICLE III: PURPOSE**

#### Section 1. PURPOSE

The purpose of this Commission is to provide technical advice and to recommend appropriate courses of action to the Pueblo Area Council of Governments Board of Directors and PACOG/MPO staff on current and emerging transportation issues, goals, plans, and programs affecting Planning and Management to the PACOG region. The advice and recommendations will address at least the Transportation Improvement Program, Unified Planning Work Program, and the Long-Range Transportation Plan.

#### **ARTICLE IV: MEETINGS, VOTING & QUOROM**

#### Section 1. PUBLIC MEETING

All meetings of the Commission and its sub-committees are open to the public. Citizens are welcome to attend meetings and may express their opinions at such times as designated by the agenda or when recognized by the Chairperson.

#### Section 2. REGULAR MEETINGS

There shall be a regular monthly meeting of the Commission or as needed. PACOG/MPO staff shall fix the time, date, and location for the meeting.

If neither the Chairperson nor the Vice-Chairperson are in attendance, then the meeting will be cancelled or postponed.

#### Section 3. SPECIAL MEETINGS

Special meetings of the Commission may be called at the discretion of the PACOG/MPO staff in consultation with the Chairperson or by written petition by any three (3) Commission members emailed, mailed, or delivered personally to the Chairperson with a copy to the PACOG/MPO staff liaison. The PACOG/MPO staff shall fix the time, date, and location for holding any special meeting. Public notice shall specify the nature of all business to be conducted at such meetings. Business transacted at all special meetings shall be confined to the purposes stated in the notice of the meeting. Once the special meeting is posted, the agenda item cannot be changed.

Online/Zoom voting is allowed.

#### Section 4. PLACE OF MEETING

Meetings may be held virtually, in-person or in combination. The Commission may designate any place as the place for any regular, or special meeting called by the Commission. Unless so designated, the Commission shall meet at the offices of PACOG/MPO at 211 E. D Street, Pueblo, CO 81003.

#### Section 5. NOTICE OF MEETING

Written or printed notice stating the place, day, and hour of the meeting and in case of special meeting, the purpose for which the meeting is called, shall be delivered not less than 24 hours before the date of the meeting, either personally, by electronic notification or by mail, to each member of the Commission entitled to vote at such meeting. Notice shall be placed in the front foyer bulletin of the Pueblo City Hall, Rawlings Library, and Pueblo County Courthouse.

#### Section 6. VOTING

Voting members of the Commission shall be entitled to one (1) vote on all matters brought before a regular or special meeting of the Commission. No anonymous votes. Proxy voting is only allowed if the voting member is absent. They can designate a representative to vote on their behalf, but must notify staff in writing, 24 hours prior to the meeting if they have not previously designated their representative. All issues shall be settled by a majority vote.

Voting by email or by mail is not allowed. Voting will be done only in regular meetings or when a special meeting is called. Anonymous voting can be held if decided on by the TAC.

#### Section 7. QUOROM

A meeting shall be considered in quorum if five voting members of the commission are in attendance. A quorum shall be necessary for the transaction of any official business at any meeting of the Commission. A representative may participate and vote via phone, internet, or in-person.

Membership will be updated, identified, and culled, if necessary, to clearly show who can vote.

#### Section 8. PROCEDURE

The latest version of Robert's Rules of Order shall govern the conduct of business at all meetings of the Commission and its sub-committees except when such Rules conflict with these bylaws.

#### Section 9. SECRETARIAL DUTIES

The PACOG/MPO staff will meet the secretarial needs of the Commission and shall keep the bylaws as amended, minutes of all meetings of the Commission, a current membership list containing the names, addresses and telephone numbers of all Commission members, and all other official documents of the Commission.

#### **ARTICLE V: MEMBERSHIP**

#### Section 1. COMPOSITION AND REPRESENTATION

All PACOG member entities in the Pueblo County area are eligible for voting membership on the Commission. Entities will be members upon submittal of a request for membership and identification of a representative, subject to approval by the PACOG Board of Directors.

- Traffic Engineer

#### Transit and Aviation Voting Members:

- Pueblo Transit Director
- Director of Aviation

#### **Pueblo County Voting Members:**

- Director of Public Works
- Deputy Director of Architecture, Engineering and Sustainability

#### Pueblo West Metropolitan District Voting Members:

Engineering Manager

#### Colorado City:

Representative that resides in Colorado City or Rye

#### <u>Citizens Advisory Committee (CAC) 5 members:</u>

- Pueblo City Planning and Zoning Commission Voting Member:
  - One member from the Pueblo City Planning and Zoning Commission

- Pueblo County Planning Commission Voting Member:
  - One member from the Pueblo County Planning Commission
- Pueblo ADA Advisory Committee Voting Members:
  - One member from the Pueblo ADA Advisory Committee
- Pueblo Active Community Environments (P.A.C.E) Voting Member:
  - o One member from the Pueblo Active Community Environments
- Pueblo Plex Representative:
  - o One member from the Pueblo Plex
- One At Large Citizen

PACOG/MPO staff and Colorado Department of Transportation (CDOT) personnel are non-voting members of this Commission and all sub-committees. All members shall be entitled to an alternate who shall be selected in the same manner as the regular member. Members can only change alternates once a year, unless an unforeseen circumstance forces the selection of a new alternate.

PACOG/MPO staff advise that TAC members bring their alternates to at least one (1) TAC meeting a year.

#### Section 2. ADDITIONAL CRITERIA

Members must meet the following additional criteria to be selected:

- A. Must demonstrate technical background and/or understanding of transportation issues in Pueblo County.
- B. Must be able to attend Commission meetings and to assist in data-gathering, analysis and other activities of the Commission when requested by the Commission to so do.
- C. Must be in good standing with the PACOG Board of Directors or TAC

#### Section 3. SELECTION

The PACOG Board of Directors shall approve all applications for membership and nominations for primary and alternate representatives from member entities. It reserves the right to review and approve/disapprove or withdraw that approval at any time.

To select the at-large citizen, a Call for Applications shall be placed at minimum a month before the November TAC meeting. In November TAC shall select a favored candidate at their discretion, to be approved by the PACOG Board of Directors.

#### Section 4. TERM OF MEMBERSHIP

A full term of membership is three (3) years, which shall run from January 1 of the first year through December 31 of the third year. An individual appointed to fill a vacancy, the duration of which is longer than one and a half years, shall be considered to be appointed to a full term. There is no limit to consecutively served terms.

PACOG member entities, TAC members serving at the appointment of a member-organization, PACOG/MPO staff, and CDOT are exempt from terms of membership.

#### Section 5. ABSENTEEISM

Individuals missing three (3) consecutive, regularly scheduled meetings, or a total of four (4) regular meetings, without prior notification and approval by Staff, during a twelve-month period shall be automatically reviewed by the PACOG/MPO Staff for possible termination. When a representative has been absent, unexcused, for the second consecutive time or has been absent, unexcused, for the third time in any twelve-month period, the Chairperson shall send, or cause to be sent, in reasonable time a letter to such member at their address as entered on the Commissions books, informing such person that another absence shall result in their membership being reviewed. If attendance at meetings does not improve, removal from Commission will be performed by PACOG/MPO staff.

#### Section 6: VACANCIES AND APPOINTMENTS

All vacancies shall be filled by the process outlined in Article V Section 1-5.

#### Section 7: RESIGNATIONS

Members and representatives are encouraged to send written notice of intent to resign to the PACOG/MPO Staff and a copy to the Commission Chairperson as soon as possible but at least one (1) month before the termination date.

#### **ARTICLE VI: OFFICERS**

#### Section 1. Officers

Officers of the Commission shall consist of a Chairperson and Vice-Chairperson.

#### Section 2. Selection of Officers

Only voting members of the Commission are eligible to be officers. Officers may be self-nominated or nominated by other TAC voting members. Nominees shall be presented to the membership for election at the November meeting each year. Election shall be by paper ballot with a majority vote electing the officers. Service as an officer is voluntary and not compensated.

#### Section 3. Duties of Officers.

The Chairperson shall preside at all meetings of the Commission, assure effective, efficient and timely conduct of the Commission's meetings, work closely and coordinate with the assigned PACOG/MPO staff liaison person on developing annual objectives of the Commission to be communicated to and approved by the PACOG Board of Directors, perform such other duties as may be assigned from time to time by the Commission or requested by the PACOG staff assigned to the Commission and attend Board of Directors meetings when possible and/or if requested by the PACOG Board's Chairperson. The Vice-Chairperson shall serve as an ex-officio non-voting member of all sub-committees created by the Commission, be responsible to the PACOG Board of Directors to assure that all sub-committees are accomplishing their objectives, and keep the Chairperson updated on subcommittees. The Vice-Chairperson and Chairperson shall be responsible for selecting and appointing all Chairpersons of sub-committees. In the event of an absence of the Chairperson or in the event of their inability to act or if the office is vacant, the Vice-
